18/07/10 TO RECEIVE ANY UPDATES ON THE SITING OF BENCHES

It was reported that works for the base for the replacement bench at the corner of Buslingthorpe Road and the A46 had been booked for August.

Cllr Boryszczuk was dealing with the replacement bench for outside the Memorial Hall and hoped to have it in place by the end of the month. The bench had been donated in memory of John and Jenny Northing by family members and would face what was the shop that they ran. A request had been made by an ex-resident to purchase the concrete ends of the bench being removed. Following a vote it was unanimously **RESOLVED** that Cllr Boryszczuk could accept what he considered to be a reasonable offer on behalf of the Council.

Following a vote it was unanimously **RESOLVED** to purchase and install 2 benches at a cost of \pounds 225 each plus installation costs of up to \pounds 500, using the Councillors Initiative Fund received from ClIr England and S106 funding. One bench would be placed in the play area and one at the entrance to the playing field as requested by residents. The benches would be ordered in grey if available or in brown.

18/07/11 TO REPORT ON ANY UPDATES REGARDING THE UNDERGROUND ELECTRICITY INSTALLATION ON THE PLAYING FIELD.

It had been reported that repairs to the playing field had been completed. There had been no further updates on wayleave payments. The Clerk would continue to pursue this.
