Suggestions for the play area included equipment for imaginary play, climbing, slides and sand pits. It was agreed that a sand pit would be difficult to keep animals out of. A further request was received for a bench at the entrance to the playing field and more seating areas on the play area. Following a vote it was unanimously **RESOLVED** to apply for funding to try and meet the improvements suggested and required.
